Cioffi, the undersigned Affiant, being first duly cautioned as to law, and being of sound mind, sober and able to offer competent testimony, being over the age of legal majority (D.O.B. 8/8/89) and having firsthand knowledge of the facts herein, do hereby attest, affirm and depose, that:

- 1). I, the Affiant herein, do hereby state, that: I hereby knowingly, intelligently and voluntarily, waive my fifth Amendment right against self-incrimination, now and at any and all future court proceedings.
- 2). I, the Affiant herein, do hereby state, that: My father, Anthony Cioffi, Jr., never had any type of inappropriate physical or sexual contact or relationship with me, in any way, at any time or place.
- 3). I, the Affiant herein, do hereby state, that: At the young age of about 7, a Trumbull County prosecutor have asked me if my father, Anthony Cioffi, Jr., have ever done anything sexual to me. My answer to him was NO.
- 4). I, the Affiant herein, do hereby state, that: I have asked my mother, April M. Arnio, if my father, Anthony Cioffi, Jr., had ANY involvement to the allegations made by, Anthony Richard Cioffi, and Matthew Antonio Cioffi. The answer I got from my mother was NO.
- 5). I, the Affiant herein, do hereby state, that: I have been asked in 1996 by a counselor at Valley Counseling if my father, Anthony Cioffi, Jr., had done anything sexual to me. My answer to the counselor was NO.
- 6). I, the Affiant herein, do hereby state, that: I have been asked in 1996 by a caseworker at the Trumbull County Children Service Board, if my father, Anthony Cioffi, Jr., had done anything sexual to me. My answer to the caseworker was NO.
- 7). I, the Affiant herein, do hereby state, that: At a young age of about 7 and 11 years ago so, I do not remember the names of the prosecutor, counselor or the caseworker.
- 8). I, the Affiant herein, do hereby state, that: The Trumbull County prosecutor have asked my mother, April M. Arnio, if my father, Anthony Cioffi, Jr., had done anything sexual to me. The answer my mother gave was NO.

- 9). I, the Affiant herein, do hereby state, that: The counselor from Valley counseling have try to get me to say, that my father, Anthony Cioffi, Jr., had done sexual things to me. My answer to the counselor was, No I will not lie.
- 10). I, the Affiant herein, do hereby state, that: I have asked my mother, April M. Arnio, if she was with my father, Anthony Cioffi, Jr., back in 1991 when the alleged allegations was to have happen. My mother would not answer this question for me.
- 11). I, the Affiant herein, do hereby state, that: I have NOT been influenced, pressured or coerced in any way, by any person or event, at any place or time, to execute this instrument or to make any statements and attestations set forth herein.
- 12). I, the Affiant herein, do hereby state, that: I have had absolutely no contact, in any way, shape or form, with my father, Anthony Cioffi, Jr., in over ten (10) years.
- 13). I, the Affiant herein, do hereby state, that: I have had absolutely no contact, in any way, shape or form, with any members of my father's side of the family, in over ten (10) years.
- 14). I, the Affiant herein, do hereby state, that: All statements, and attestations I have set forth herein, were made knowingly intelligently and completely voluntarily.
- 15). I, the Affiant herein, do hereby state, that: I am more than willing and able to be deposed, to cooperate fully and answer truthfully at such deposition, any and all questions put before me, specifically including, but not limited to all statements and attestations set forth within this instrument.
- 16). I, the Affiant herein, do hereby state, that: I am more than willing to testify truthfully, under oath, to all statements and attestations set forth within this instrument, in any court of competent jurisdiction, at any time.
- 17). I, the Affiant herein, do hereby state, that: I am willing to submit to examination by a neutral psychologist or psychiatrist, by both state and private entities, with no interest in prosecution or defense, who might help confirm or deny the credibility of my present statements.
